VII. MIDDLE EAST CONGRESS ON POLITICS AND SOCIETY

GENERAL RULES

- The languages of the congress are Turkish and English. (Presentations in Turkish, English, and Arabic will be accepted.)
- Participation from Turkey will be limited to 45% of the total number of participants.
- All abstracts intended for presentation at the congress will undergo double-blinded peer review.
- To participate, abstracts of 250–300 words along with personal information must be submitted via the online form provided on the website by July 28, 2024.
- Participants will have the opportunity to have their papers published in the Congress Full Text Booklet or Turkish Journal of Middle Eastern Studies after undergoing an editorial process. Full papers should be between 4,000 and 6,000 words and must be submitted to the congress email address by September 6, 2024.
- The acceptance, reserve, or rejection status of abstracts will be announced on August 15, 2024.
- The participation fee for accepted papers will be ₺1500 for Turkish citizens and €90/\$100 for international participants.
